




Scope

At the request of the Washington State Legislature (WSL), BuildingWork, LLC conducted an assessment of the capital needs for public libraries in Washington state rural distressed counties. The study was funded by WSL, and the implementation was assisted by the Washington State Department of Archaeology and Historic Preservation (DAHP). This assessment report defines the capital need improvements and provides a budget estimate for each of the one hundred and eleven public libraries located across the twenty-one rural distressed counties in Washington state. A rural distressed county, as defined by the Office of Financial Management (OFM), is a county with a three-year average unemployment rate of greater than or equal to 6.2%. The report also includes an evaluation of the local bond and levy funding capacity for each library district that has a library included in this assessment report. The assessment of the capital needs of public libraries in rural distressed counties provides the Washington State Legislature with an overall budget for needed improvements to develop a statewide grant program for these libraries and their communities.

The OFM publishes a list of distressed areas yearly. At the start of the assessment period, the most recent distressed area list published by the OFM was in early 2018, listing the distressed areas for 2017. Distressed areas are counties where the three-year unemployment rate is at least 20% higher than the statewide average. For the 2017 list, the three-year period ranged from January 2015 to December 2017. In 2017 the statewide average three-year average unemployment rate was 5.2% and distressed counties have a three-year average unemployment rate greater than or equal to 6.2%. The OFM's 2017 list identified twenty-one counties in Washington as a distressed area.¹

Public libraries and library districts operating within these counties were identified using the online directory of Washington libraries provided by the Washington State Library.² BuildingWork identified one hundred and eight public libraries and thirteen library districts within the twenty-one rural distressed counties. Eleven

of the libraries identified operate independently of a library district. Several library districts operate across county lines and four library districts also operate libraries in non-distressed counties. By request, the three libraries of the Colville Tribal Libraries district were added to the assessment.³ In total, one hundred and eleven libraries across fourteen library districts were assessed.

It should noted that there are approximately seventy-five additional libraries in the nine rural counties that are not covered in this study. These libraries serve rural communities that are in counties that do not meet the unemployment threshold to be considered "Distressed". However we, and others, suggest that the "Distressed" threshold is somewhat arbitrary, and recommend that the study be expanded to include the remaining libraries in rural counties of the state. The nine additional rural counties are Asotin, Chelan, Garfield, Island, Kittitas, Lincoln, San Juan, Walla Walla, and Whitman.

The assessment of the public libraries was initially conducted by a self-reporting survey questionnaire. There was an 88% response rate with ninety-nine of the one hundred and eleven surveys returned. A few libraries had recently undergone a building assessment and that assessment report was sent in addition to or as a replacement of the survey questionnaire provided by BuildingWork. Twelve libraries did not complete the survey questionnaire. Reasons for not returning the survey varied between libraries; some were housed in other facilities (such as public schools or a small room attached to city hall), some did not have the staff available to complete the survey, and some library districts chose not to complete the survey for their libraries housed in rental facilities. Two of the libraries that did not initially return the survey were later scheduled for a site visit. Of the one hundred and eleven libraries surveyed, one hundred and one libraries underwent a capital needs assessment and the remaining ten libraries that did not complete a survey nor were selected for a site visit underwent a cursory assessment.

Map 2. Public Libraries in Rural Distressed Counties



The surveyed libraries are divided into four categories of need:

- 1. limited improvements;
- 2. renovation;
- 3. renovation and expansion;
- 4. new library building.

These categories summarize the scope of improvement needs and determined the budget estimate calculation method. The buildings surveyed included buildings designed and built as libraries and buildings re-purposed into a library; buildings owned by the library or library district and libraries in rented buildings or spaces; and libraries housed in historic and non-historic structures. For the purpose of this study, historic structures are defined as buildings known to have been built fifty or more years ago (1969 or earlier), independent of the building's historical significance.

Identifying the libraries in historic buildings is an important part of this assessment. Buildings that are listed in the National Register of Historic Places (NRHP), may qualify for a few additional grant programs specifically available for historic listed properties. Other grant resources include: USDA Rural Development grants, low-interest loans, and Washington State Department of Commerce Community Capital facilities, among others.3 Buildings in the NRHP include buildings that are individually listed, listed as a part of a thematic resource, or buildings that contribute to an historic district. While not every library located in a historic building may be listed in the NRHP, it is nevertheless important to identify these buildings. It is recommended that libraries located in historic properties, when undergoing any kind of improvement, follow the Secretary of Interior's Standards for the Treatment of Historic Properties with Guidelines for Preserving, Rehabilitating, Restoring and Reconstructing

Historic Buildings. The rehabilitation of historic buildings often costs more per square foot than rehabilitation of non-historic buildings, but both are almost always less expensive than demolition followed by new construction.

An evaluation of the local bond and levy funding capacity of each library district that has a library included in this assessment was conducted by D. A. Davidson & Co. The evaluation includes single library districts but does not include those libraries that are not part of a library district. The report provides the total possible funds available to each library district within voted debt capacity limits (district-wide) and non-voted debt capacity limits and lists options that districts may use to raise capital for bond repayment. It also provides the potential maximum funds available to each district via a levy-lid lift, one potential source of repayment for non-voted bonds. Library Capital Facility Areas (LCFAs) are discussed, but their debt capacity limits are not calculated herein, because they would depend on the boundaries of any new LCFA. It does not guarantee that total possible funds available, either by voter approval, as a levy-lift, or other means, is achievable. The local debt capacity evaluation may be used to help library districts, library advocates, elected officials, and the Washington legislature determine a library district's ability to raise funds among its own constituents for the improvement of these libraries. The evaluation may be found in 5. Bond and Levy Capacity Study.

Purpose

Public libraries play a central role in the life and health of our communities. In addition to access to books, public libraries provide a wide range of services and support, including internet service and computer access, digital resources, meeting space, early literacy and language programs, after-school programs, senior services, and voter registration and ballot boxes. In many parts of the state, especially in small towns and rural areas, the local public library is the primary, and in some cases the only, public space that is accessible and free. In short, public libraries, along with public schools and emergency services, are the foundation of our communities.

It is essential to invest in public libraries. Libraries are third places; a location that is not a home or work that provides opportunities for social interaction and engagement while establishing a sense of place and community. Libraries provide services that would otherwise be unavailable to the public. Yet libraries are historically underfunded.⁵ Many public libraries suffer from decades of deferred maintenance, resulting in poor lighting, leaking roofs, and inadequate HVAC for hot and cold weather. Lack of funding often shuffles libraries into tiny spaces or force libraries to share space with other public entities. The lack of a proper sized space is a detriment to the services and opportunities that a public library is able to offer to its community. Without adequate spaces, public libraries are unable to designate areas for computers leading to limited or no public computer accessibility; libraries are unable to offer space specifically for children or teens, limiting the opportunities for programs designed to promote childhood development and makerspaces for teens; and due to space constraints libraries may even lack accessibility features such as ADA compliant entryways or restroom facilities that limit (often to those whom need it most) who can receive library services.


The capital needs assessment of public libraries in rural distressed Washington counties begins to redress the deficient funding of these libraries. The report provides information on improvement needs and a budget estimate for each library surveyed. This will assist the Washington State Legislature's development of a statewide grant program to support these libraries and their communities. In addition, a library's assessment report may be used by local library districts, library advocates, and library patrons and staff to prioritize improvements and begin funding initiatives for necessary building improvements, service increases, and possible renovations, expansions, or the construction of a new library building.

This report provides only a general condition assessment of a library's physical and programmatic needs. Once deciding to undertake an improvement process, libraries should employ a design professional to obtain an updated list of improvement needs and cost estimate.

The initial research for this assessment identified the rural distressed counties in Washington state and the libraries and library districts that operate within them. Due to the number of libraries in the assessment, their location across Washington state, and the set budget provided, it was cost prohibitive to conduct a site visit to each individual library. Instead, BuildingWork designed a survey questionnaire to aid with the capital needs assessment of these libraries. The questionnaire was designed to assess the needs of both the library building and the library's programming. Phone interviews with the managers and directors of the libraries or library districts provided additional information to the returned surveys. Nineteen libraries were then chosen for site visits. The site visits provided an opportunity to see the libraries first-hand, meet with library managers, and gather more information about the specific needs of the library. The survey questionnaire, phone interviews, and site visits provided the basis for the assessment of each library's improvement needs and corresponding capital needs budget estimate.

Survey Questionnaire

The survey questionnaire was distributed to library directors via email in October 2018, with follow-up phone interviews. Directors and their facility managers and staff were provided with instructions and given a period of four weeks to complete and return the survey. Libraries that did not returned a survey were followed-up with and given an additional two weeks to complete the survey.

The survey requested information on the size, design, and construction of the building. It included questions regarding the library's programmatic needs and the condition of the building's interior and exterior. The survey was divided into three parts: General Information, Library Function Needs, and Library Building Condition. The third part was further divided into seven parts: Site, Architecture - Exterior, Structural, Architecture - Interior, Mechanical Systems, Plumbing Systems, and Electrical Systems. The survey included a list of condition terms as guidelines to assist the surveyor and to create a consistent assessment across all libraries surveyed. Conditions were defined as follows:

Good – in new or well-maintained condition, with no visual evidence of wear, damage, or deficiency;

Fair – some visible wear but still in serviceable and functional condition;

Poor — subjected to hard or long-term wear. Nearing the end of useful life;

Critical – has reached the end of serviceable life. Replacement now is necessary

In addition, libraries were asked to provide photographs of the library and surveyed items to provide additional documentation for assessment.

Initial Budget Estimate

Once the survey period closed the survey questionnaires were processed, analyzed, and an initial budget estimate was established. The initial budget estimate helped inform which libraries were chosen for site visits. At the beginning of 2019, DAHP requested an initial budget estimate for the twenty libraries in most need of capital improvements for use in the 2019 legislative session. This resulted in eleven rural libraries (seven in rural, distressed counties included in this survey) receiving funds in the 2019-2021 Washington State Budget Grants to improve their building infrastructure or build a new library.

Site Visits

Nineteen libraries were chosen from nine library districts for a site visit. Libraries were chosen based on their historical characteristics, survey questionnaire, and initial budget estimate. The libraries selected provide a sampling of size, population served, capital needs, and historic character across a majority of Washington state rural distressed counties and library districts. Two of the libraries visited received a limited visit to verify the condition of the building's exterior. The nineteen libraries selected for a site visit are:



Capital Needs Budget Estimate


The purpose of this assessment is to provide a list of capital need improvements and a corresponding capital budget estimate for each public library located in a Washington rural distressed county. The initial budget estimates were refined to provide a more detailed and representative budget estimate for each of the one hundred and eleven libraries surveyed. More details on the budget estimation may be found in 3. Summary of Library Capital Needs. The budget estimate for each library surveyed is included in the individual library assessment reports found in 4. Capital Needs Assessment Reports.











The budget estimate analysis for each library is based on the improvement needs identified through the survey questionnaire, phone interviews, and site visits. A library's improvement needs include both the physical needs of the library building and the programmatic needs of the library's services. With knowledge of the library's improvement needs, the library was sorted into one of four capital needs categories: limited improvements; renovation; renovation and expansion; and new library building. These categories determined how the budget estimate for the capital needs was calculated. For library buildings requiring a renovation the building's age and status as a historic or non-historic building is also taken into account.

Physical and Programmatic Needs

The physical needs of the library are identified as needs related to the interior and exterior of the building. Architectural needs are design elements, materials, and spaces that require special attention based on their original conception, actual condition, future needs, and ADA compliance. Site needs relate to landscape and parking. Structural needs include the foundation, roof, and general stability of the building. System needs refer the mechanical, electrical, and plumbing systems of the library that include (but is not limited to) HVAC, toilet fixtures, lighting, energy efficiency fixtures, and WiFi technology.

The programmatic needs of each building relate to the areas in the library used by library patrons and staff. These functional needs are specific spaces within the library including: areas for children, teens, and adults; small and large study rooms for independent and group study; meeting rooms; computer areas; quiet areas; storage areas; and staff working areas (sorting areas, work areas, circulation area, offices, and breakrooms). The American Library Association's "Guidelines for Determining Minimum Space Requirements" is also taken into consideration of each library's programmatic needs (see page 225). This guideline lists the minimum space recommended for public libraries based the size of the population they serve.

Capital Needs Budget Estimate Calculation

To determine the budget estimate for each library's capital needs improvement, BuildingWork established a standard cost per square foot for the renovation of a non-historic building, the renovation of a historic building, and for new construction. The budget estimate for each library categorized as needing a renovation, renovation and expansion, or new library building is calculated by multiplying the cost per square foot by the square footage the improvement encompasses. The cost estimation for libraries categorized as needing limited improvements or as no survey was completed on an individual basis (see below for more information).

The total cost per square foot is the sum of hard construction costs and soft costs. BuildingWork's expertise in the design analysis and development of numerous libraries for multiple library systems across the state informed the determination of the hard cost for improvements, renovations, and new construction. Hard costs for construction include: site development; site infrastructure; building construction; furniture, fixtures, and equipment (FFE); and construction contingency. Soft costs are calculated at 30% of the hard costs and include: AE fees; design contingency; sales tax; permit fees; and cost escalation. The estimates are listed in 2022 dollars and include a cost escalation that allows for a 5% per year cost escalation in the three years between 2019, when this assessment is published, and 2022, the likely earliest construction date.

Based on the American Library Association's (ALA) "Guidelines for Determining Minimum Space Requirements," an addition or new library building is recommended for existing libraries that are currently smaller than the recommended size for its population served as listed by the guideline. Using this guideline, all libraries should be at least 2,000 sf. Additions or new, larger library buildings are recommended for libraries that do no currently adhere to the ALA minimum space requirements. The guideline is followed for all libraries assessed in this report, with a few exceptions when the library's historic character, location, or the community's specific needs are determined to be more important than the ALA's established guidelines.

Capital Need Categories

1. Limited Improvements

Limited, specific improvements are recommended for libraries where minor interior or exterior upgrades are needed. Limited improvements may include, but are not limited to: HVAC installation, electrical repairs, ADA restroom compliance or addition, interior reorganization to create new spaces for patrons, and/or painting.

The needs budget estimate for these libraries do not use the cost per square footage calculation, since the calculation would grossly over-estimate the library's budget estimate. The budget estimate provided for these libraries is based on the specific needs listed for each library.

2. Renovation

A complete renovation of existing libraries is recommended for libraries that are appropriately sized for the population they serve and that suffer from long term deferred maintenance. These libraries require changes to their program layout, requiring an extensive interior renovation. Depending on the condition of the library building, they may also require an extensive exterior renovation.

The cost per square foot calculation used for these libraries is based on whether or not the renovation will be completed in a historic or non-historic building. For example, the budget estimate for the renovation of a 2,000 sf existing, non-historic library building at \$260 per sf is \$520,000. The renovation of an existing library in a historic building of the same size (2,000 sf) will have a budget estimate of \$714,000 (at \$357 per sf).

3. Renovation and Expansion

The complete renovation of the existing library plus an expansion is recommended for libraries that meet the same standards as existing libraries in need of a complete renovation, but are too small for the population they serve. Since additional space is needed than the existing library building provides, an addition to the current library building is suggested. The libraries with this designation are also located on a site where an addition is feasible (i.e.: there are no site limitations for a possible expansion).

The budget estimate for a renovation and expansion is the cost per square foot for the renovation of the existing building (non-historic or historic) plus the cost per square foot for a new building. For example, the budget estimate for the renovation of 1,000 sf non-historic library with a 1,000 sf addition is \$812,000.

4. New Library


A new library building is recommended for libraries that have out grown the space or structure where they are currently located. At these libraries both renovations and additions are unfeasible due to condition of the current building, cost, and/or site limitations. It is not worth investing in the current library building and the best solution of available resources is for the construction of a new building.

The budget estimate for these libraries uses the cost per square foot calculation for new library buildings. For example, at \$552 per square foot, a 2,000 sf new library building has a budget estimate of \$1,104,000.

No Survey

The ten libraries that did not complete the questionnaire nor received a site visit are categorized as No Survey. The budget estimate provided is an estimate for a new library based on the local population size.


Graph 2. Library Capital Needs Budget Summary by Need Category



The graph charts the total budget estimate for each capital need category for the one hundred and eleven libraries surveyed.




Graph 3. Library District Capital Needs Summary



Map 4. Colville Tribal Libraries Location







Map 5. East Adams Library District Locations







Map 6. Fort Vancouver Regional Libraries Locations










MID-COLUMBIA LIBRARIES

Mid-Columbia Libraries was established in 1948 to serve the unincorporated areas of the mid-Columbia region. The first branch library, opened the following year in 1949, was a Bookmobile serving communities in Benton and Franklin counties. Bookmobiles services have been continuously offered by the district since 1949. They are an essential part of the Mid-Columbia Libraries. Today the



district's Bookmobiles attend major regional events and continue to serve rural areas in the mid-Columbia region that otherwise would not have access to library services and books.

The Mid-Columbia Libraries have twelve branch libraries in Benton and Franklin counties and also serves communities in southern Adams county. Six branch libraries reside in the rural distressed county of Franklin. The libraries in this county are in need of new library buildings. 








NORTH OLYMPIC LIBRARY SYSTEM

Map 10. North Olympic Library District Locations







Map 11. Pend Oreille County Library District Locations













In Jefferson county, the independent Port Townsend library and the Jefferson County Libraries, a single library (with bookmobile) library district, are located on the Quimper Peninsula in the northeast part of the county. The Cathlamet Public Library is the only public library operating in Wahkiakum county. The Ocean Shores library in Gray's Harbor county and the four libraries located in Cowltiz county are independent libraries operating in counites with larger library districts (Timberland Regional Library District and Fort Vancouver Regional Library District, respectively).





RURAL LIBRARY DISTRICT LOCAL FINANCING OPTIONS

Rural library districts in Washington have a number of different options for paying for capital projects with local tax dollars. As taxing districts, they have the power to issue tax-exempt municipal bonds, which is a relatively low-cost borrowing method; however, an adequate repayment source must be identified.

Option 1: Issue Voter-Approved Tax-Exempt Bonds ("Voted Bonds") for District-Wide Improvements

For large capital projects that make improvements throughout the library district, the best strategy may be to ask voters to approve a bond levy. When voters approve a bond levy, they create a repayment source for the debt in the form of a new property tax referred to as an "excess levy". The bar for passage is high, at 60%, plus there is a validation requirement, such that the results are only valid if voter participation is considered high enough (40% of the number within the district who voted in the last general election). That said, if the financed projects have broad appeal and the projects would not be affordable with nonvoted debt (further described in Option 3), voted bonds are possibly the best option. With voted bonds, debt service would be paid in full by annual excess property tax levies for the term of the bonds. The term could be up to 40 years, depending on the useful life of the projects; however, a 20-year or 30-year term may fare better with voters. A district's regular levy and potential levy lift dollars would remain available for operations.

Each library district has an assessed value ("AV") that is determined annually by the assessor or assessors of the district's county or counties. Washington State law allows library districts to issue debt with voter approval (known as "voted debt" or "voted bonds") up to a limit of one half of 1% (0.50%) of the district's AV.

D.A. Davidson & Co. estimates that annual principal and interest payments (known as "debt service") per million of 20-year, voter-approved (or "voted") bonds would be \$68,000. That is to say, a \$10 million project would cost \$680,000 per year in principal and interest payments, while a \$25 million project would cost \$1,700,000 per year, and a \$50 million project would cost \$3,400,000 per year.

Option 2: Create a Library Capital Facility Area and Issue Voted Bonds for Local Improvements

For large capital projects that might benefit only a portion of a library district, it might be difficult to obtain 60% voter approval of a bond ballot proposition district-wide. In such a case, the best option may



be to work with the County Assessor(s) relevant to the area that would benefit from the improvements to establish a Library Capital Facility Area (LCFA), a smaller subset of the district, whose voters could approve an excess levy that would apply only to the assessed value within the LCFA. Creation of an LCFA requires a simple majority vote, while bond authorization within the LCFA requires a 60% vote in favor from voters within the LCFA. A bond authorization from LCFA voters would create a repayment source for the bonds, in the form of an excess levy applied only within the LCFA boundaries.

An LCFA can have boundaries contiguous with a school district, city, fire district or other existing boundary, or it can have new boundaries.

As with Option 1, the district's regular levy and potential levy lift dollars would remain available for operations, and debt service would be paid in full by annual excess property tax levies within the LCFA for the term of the bonds. The term could be up to 40 years, depending on the useful life of the projects; however, a 20-year or 30-year term may fare better with voters.

Washington State law allows an LCFA to issue debt with voter approval (known as "voted debt" or "voted bonds") up to a limit of one and one quarter % (1.25%) of the AV within the LCFA. An Interlocal Agreement between the LCFA and the Library District would govern how the library facilities are designed, constructed, owned and operated. LCFAs are governed by 3 members of the county legislative authority from each county in which the LCFA is located, and they do not typically have paid employees.

Option 3: Issue Non-Voted Tax-Exempt Bonds

Washington State law allows library districts to issue debt without obtaining voter approval (known as "non-voted debt") up to a limit of one tenth of 1% (0.10%) of the district's AV. The non-voted bonds can have a maximum term of 6 years, so this option is not ideal for very large capital projects, where it might be more affordable to spread the cost out over a longer period.

D.A. Davidson & Co. estimates that annual debt service per million of 6-year, non-voted bonds would be \$181,000. That is to say, a \$1 million project would cost \$181,000 per year in principal and interest payments, while a \$5 million project would cost \$905,000 per year, and a \$10 million project would cost \$1,810,000 per year.



Non-voted bonds require a district to identify a repayment source. A district could make payments on non-voted debt from its regular property tax receipts. However, the district may be using all of its regular property tax receipts to fund operations, and may need to identify new revenues to pay debt service on non-voted debt, such as grants, charitable contributions, or other legally unrestricted funds.

A key potential source of repayment would be from what is called a "levy lid lift".

In Washington, local taxing districts have their regular levies capped at a certain rate, depending on what kind of taxing district it is (fire, library, city, EMS, etc.). For libraries, the regular levy is capped at \$0.50 per thousand dollars of assessed value. However, in Washington, regular levies are not permitted to grow in step with increases in property value, presumably to protect property owners from tax bills growing unaffordable as home values appreciate. There is a formula restricting growth in the levy amount to 101% of the prior year's dollars collected (or inflation, if lower), plus the full levy on newlybuilt property and utilities such as railroads and wind farms that are assessed by the State. Because of this limit, about half of the rural library districts studied have regular levy rates closer to \$0.36 per thousand than to \$0.50 per thousand.

But a district can ask voters to approve a return to the \$0.50 rate, either for a stated period (such as 6 years, to repay non-voted bonds) or indefinitely. This is called a "levy lid lift", and it only requires a 50% vote in favor to pass. Some of the districts studied have already received voter approval for a levy lid lift.

Methodology

The following 16 pages of tables show the remaining voted and non-voted debt capacity of certain rural library districts within Washington State. D.A. Davidson obtained the assessed value information from County Assessor levy reports, and the amount of existing debt from each district's most recent audit report available from the State Auditor. (For some small districts, no financial audit is available, so we could not verify the amount of debt outstanding.) Voted debt capacity is often much higher than the amount that could reasonably be considered affordable, however.

The bottom section of each page of tables endeavors to calculate the potential additional regular property tax revenues each district might realize via a levy lid lift. The purpose of this section is to show how much additional revenue might be available for debt service for non-voted bonds each year with a 50% majority vote, and how much non-voted debt that could support.



Explanatory Example: Fort Vancouver Regional Library

Page 5 of the tables is for Fort Vancouver Regional Library (FVRL), showing the total taxable assessed value within the FRVL taxing district. We aggregated values from the Clark, Skamania, Cowlitz and Klickitat county assessor reports to arrive at the total AV of \$66.5 billion for the district. One half of one percent of that value is \$332 million, a very large sum. However, the District could only issue voted bonds if 60% of voters approve, a high hurdle for such a widespread electorate. Bond projects would need to benefit many different communities throughout the district and the average cost to taxpayers would need to be something voters consider affordable for any bond measure to pass.

FVRL also has the ability to issue \$66.5 million of non-voted debt. This would not require voter approval; however, the district would need a revenue stream to pay debt service on any non-voted bonds. Realistically, unless a district is running a significant operating surplus or is expecting payments from grants or gifts, they would still need to obtain voter approval (a simple majority vote) for a levy lid lift to pay debt service. For non-voted debt, the term of the debt can be only up to 6 years, so the annual debt service on a \$66.5 million non-voted bond issue would be high, at approximately \$12 million per year.

As the third table shows, only \$9 million per year could potentially become available through a levy lid lift. That could pay the debt service on roughly \$50 million of debt, using our calculation of \$181,000 annual debt service per million of non-voted debt. That said, the district would be devoting the levy lift funds for 6 years to capital, making them unavailable to support operating needs.

According to the December 31, 2017 audited financial statements for the FVRL, the district has no existing voted or non-voted debt. Any debt incurred since then would reduce its remaining available debt capacity.

As noted at the bottom of page 5, there do exist two Library Capital Facility Areas (LCFAs) within FVRL: Vancouver Library Capital Facility Area and Three Creeks Library Capital Facility Area. While LFCA debt does not reduce the library district's debt capacity, voters who reside within those areas already pay excess levies to repay library-associated debt. Taxpayers within the Fort Vancouver LCFA pay an excess levy of just under \$0.15 per thousand in 2019 for capital (\$75 per year for a \$500,000 home). As a result, they may be less likely to vote in favor of an additional library district-wide excess levy unless they believe the funded projects would benefit their local community. The AV within the LCFA constitutes 36% of the Fort Vancouver Regional Library AV.



Historical Library Elections

The feasibility of obtaining voter approval for a bond issue is very hard to assess without specifics on the exact projects to be financed or survey look at the history of library elections within Washington for some indicators of what has been successful in the past (while acknowledging that results about how community members feel about the importance of those projects and the affordability of an excess levy. However, we can priorities vary in different electorates).

TRIBAL LIBRARY LOCAL FINANCING OPTIONS

Tribal governments can issue tax-exempt bonds in the municipal markets, secured by the full faith and credit of the tribal government. As sovereign nations, tribes do not have statutory debt capacity limits like general municipal library districts. The ability of a tribal government to access the capital markets to finance library capital facilities is based on the tribe's financial strength. Typically, interest rates and borrowing costs are higher than for other municipal governments.

CITY-OWNED LIBRARY LOCAL FINANCING OPTIONS

Cities in Washington can issue either tax-exempt bonds for library improvements with either voter-approved bonds or non-voted bonds, if general fund revenues will be sufficient to pay annual debt service. A city's non-voted bonds could have a longer repayment term of 20 or 30 years, in contrast to rural library districts. Non-voted city bonds are limited tax pledges of the city to repay the debt from available regular property taxes. Voted bonds would require voter approval and would be repaid with an excess property tax levy. A 60% supermajority must vote in favor to pass a voted city bond.

A city may issue voted debt up to 2.5% of assessed value for general purposes, including libraries.

A city may issue non-voted debt up to 1.5% of assessed value. Once issued, non-voted debt reduces the city's voted debt capacity.



ADDENDUM: RURAL LIBRARY DISTRICT TAXING POWERS

Rural library districts in Washington are authorized to levy both "regular" property taxes and "excess" property taxes.

Regular Property Taxes

Rural library districts are authorized by RCW 27.12.050 to make an annual regular property tax levy of up to \$0.50 per \$1,000 of assessed value for the establishment and maintenance of library service for their districts. This regular levy is subject, however, to limitations described below under the heading "Limitations on Regular Property Tax Levies." Regular property tax levy receipts may be used for the payment of the principal of and interest on non-voted general obligation bonds, costs of maintenance and operation, or for any other lawful District purposes.

Limitations on Regular Property Tax Levies

Regular property tax levies are subject to limitations under State law, which may require Rural library districts to levy less than the \$0.50 per \$1,000 maximum stated above.

Property Tax Levy Limits. Chapter 84.55 RCW imposes limitations on the ability to increase tax levies each year. The regular property tax increase limitation limits the total dollar amount of regular property taxes levied by an individual local taxing district to the lesser of (i) 101 percent of the highest levy in the three previous years (excluding new construction, improvements and State-assessed property and wind-power turbines assessed as real property) or (ii) inflation, which is statutorily defined as the percentage change in the implicit price deflator for personal consumption expenditures for the United States as published for the most recent 12-month period by the Bureau of Economic Analysis of the Federal Department of Commerce in September of the year before the taxes are payable. The property tax levy can be increased by an amount in excess of these limits, but to a maximum of 101 percent, based on a finding of substantial need by the governing body of jurisdiction.

With a majority vote of its electors, a taxing district may levy, within the overall rate limitations of chapter 84.52 RCW described below, more than what otherwise would be allowed by the tax increase limitation indefinitely or for a limited period or to satisfy a limited purpose, as allowed by RCW 84.55.050. This is known as a "levy lid lift."

Since the regular property tax increase limitation applies to the total dollar amount levied rather than to levy rates, increases in the assessed value of all property in the taxing district (excluding new construction improvements and State-assessed property) which exceed the rate of growth in taxes allowed by the limit factor result in decreased regular tax levy rates, unless voters authorize a higher levy. Decrease in the assessed value of all property in the taxing district (including new construction, improvements and State-assessed property) or increases in such assessed value that are less than the rate of growth in taxes imposed, among other events, may result in increased regular tax levy rates.



Excess Property Taxes

Rural library districts may also impose "excess" property taxes, which are not subject to limitation, when authorized by a 60 percent majority popular vote, as provided in Article VII, Section 2, of the State Constitution and RCW 84.52.052. To be valid, such popular vote must have a minimum voter turnout of 40 percent of the number who voted at the last general election in the taxing district, except that one-year excess tax levies also are valid if the number of voters approving the excess levy is at least 60 percent of a number equal to 40 percent of the number who voted at the last general election in the taxing district. Excess levies also may be imposed without a popular vote when necessary to prevent the impairment of obligation of contracts.

LIBRARY CAPITAL FACILITY AREAS

Under chapter 27.15 RCW, upon the request of a library district and each affected city, and with the approval of the voters, a library capital facility area can be established to acquire, construct, equip, and finance library capital facilities. The board of trustees of the library district would work with the county or counties affected to place two propositions on the ballot. The first would, by majority vote, establish the LCFA boundaries, and the second would, by 60% supermajority vote, provide for the issuance of general obligation bonds to finance capital facilities in the LCFA and the imposition of an excess levy to retire the bonds. Each affected city must also make the same request of its county.

LCFAs are not authorized to levy regular property taxes.

An LCFA is authorized to levy an excess property tax levy when approved by 60% of those voting in the election at which the total number of persons voting is not less than 40% of the total votes cast in the last general election. LCFAs are authorized to collect property tax levies on the bonds.

An LCFA is an independent taxing district that is separate from the county or counties, library district and any city in which it is located. **LCFA debt is not debt of the rural library district in which it is located.**

Under chapter 27.15 RCW, library capital facility areas are authorized to issue voter-approved general obligation bonds to finance library capital facilities not exceeding an amount, together with existing debt of the LCFA, equal to 1.25% of the taxable AV of the LCFA. An LCFA does not have authority to issue debt without voter approval.

LCFAs do not need to have any employees. The county treasurer can act as *ex officio* treasurer of the LCFA, collecting property tax levy and making payments on any bonds.



An LCFA is governed by three members of the county legislative authority from each county in which the LCFA is located. If a county legislative authority has more than three members, the three members of the LCFA's governing board are chosen by the full membership of the county legislative authority. If an LCFA is located in more than one county, the counties may agree to be represented by fewer than three members.

Once formed, an LCFA may construct, acquire, maintain and remodel library capital facilities and it may contract with a county, city, town or library district to design, administer the construction of, operate or maintain a library capital facility financed under 27.15 RCW. The LCFA may hold title to the facilities or may transfer or sell title to a government in which the facilities are located.

An interlocal agreement typically governs ownership of the facilities and the respective roles of the LCFA, the library district, and any other affected governmental entities.

Once an LCFA has issued general obligation bonds, the area may be dissolved only by a majority vote of its governing board when all general obligation bonds issued by the LCFA have been discharged and any other contractual obligations of the LCFA have either been discharged or assumed by another governmental entity.

Because it takes only 50% approval to establish an LCFA and 60% approval to approve a bond measure for the LCFA, there have been instances when an LCFA is created but the associated bond measure does not pass. State law allows for a second attempt to obtain the 60% supermajority. If the bond measure fails twice, the LCFA will be dissolved.







Making libraries a priority: how an Evergreen student is working for rural communities

Waylon Robert has the presence of an old soul. His smile, mannerisms, and style of dress are memorable, and his fascination with history is evident in his studies and conversations.

Perhaps this cocktail of personality traits helped the 20-year-old Evergreen student recently secure \$250,000 in state funding to help restore a rural library in Grays Harbor County; but it's also his fierce tenacity, drive, and compassion.

"Libraries are incredibly relevant," says Robert. "They're a safe place for kids, a job-finding resource, and for some people, libraries are their only means of internet access."

Through Evergreen, Robert connected with the right people to conduct his research and drive that message home. He was offered an internship position with the City of Hoquiam, working under City Administer and Evergreen alumnus Brian Shay.

"I knew the work was going to be challenging," admits Robert. "I also knew the best way to learn about a community is to talk to a reporter. I found John Hughes from Aberdeen's newspaper, *The Daily World*—he's a walking encyclopedia and well-respected in the Grays Harbor community and he's now the state historian."

It was through Shay and Hughes that Robert began to understand the people, economy, and history of Grays Harbor County, including Aberdeen and Hoquiam. The Hoquiam Timberland Library became Robert's office, and he saw firsthand the beauty of the historical building, and the importance of its resources for locals.

"Waylon is very involved with historic renovation—he saw the need that so many of these libraries have. Most people don't know that public libraries are owned by the city and to have the funds to maintain a huge historic building gets challenging," says Shay. "But Waylon helped us—he can be very persuasive. His successes far exceeded my expectations."

It was also through Shay and Hughes that Robert grew his support team. He was introduced to former Secretary of State Sam Reed, Representative (and Evergreen alumnus) Brian Blake, and State Librarian Cindy Aden, among other important influencers.

"Ninety percent of politics is doing your homework, and communication and relationships are vital," says Robert. "There are a lot of good ideas in the legislature, but you really need a champion to get on board."

With his army of supporters behind him, Robert continues to raise money, pulling in around \$40,000 in additional funding from the community, with half from an anonymous donor

After finishing the Hoquiam project Robert then secured an \$80,000 budget proviso. The proviso will finance a capital inventory for libraries in the 21 distressed counties. If the need is great enough Robert will pursue the creation of a grant program for libraries in Washington's capital budget. Robert is currently working on a 16-credit Independent Learning Contract (ILC) to continue these efforts.

At Evergreen, Robert is also on the Geoduck Student Union. Last year, he brought the roving Washington Supreme Court to campus, and this year he's spearheading a summer grant fund for students who can't afford unpaid internships.

"You can really make your education at Evergreen whatever you want it to be," says Robert. "I got to have the legislature as my classroom, state representatives as my professors, and at the end of the day I had the Evergreen woods to come home to."
